NOTICE ON THE PROCESSING OF PERSONAL DATA PURSUANT TO ARTICLES 13 AND 14 OF REGULATION (EU) 2016/679 for the implementation of the Interreg Programme VI-A Italy– Slovenia 2021–2027

In compliance with Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016, on the protection of natural persons with regard to the processing of personal data and on the free movement of such data (hereinafter also referred to as "GDPR"), as well as Legislative Decree no. 196 of 30 June 2003 (Privacy Code), as amended by Legislative Decree no. 101 of 10 August 2018, which aims to protect the rights and fundamental freedoms of natural persons, particularly the right to the protection of personal data, the user is hereby informed about the methods of processing personal data provided during the implementation of the Interreg Programme VI-A Italy–Slovenia 2021–2027.

Obligation to Provide Data and Consequences of Refusal The provision of data is necessary, and any refusal to provide them, in whole or in part, may result in the impossibility for the Data Controller to properly carry out all obligations, including the performance of a task carried out in the public interest or the exercise of official authority vested in the Data Controller.
Legal Basis	The legal basis for the processing is Article 6, paragraph 1, letter e) of the GDPR, as the processing is necessary for the performance of tasks carried out in the public interest and for the institutional purposes related to the management of the Interreg Programme VI-A Italy–Slovenia 2021–2027. Specific legal references include Regulation (EU) 2021/1060 (Art. 49) and Regulation (EU) 2021/1059, which govern the management of European funds in the framework of territorial cooperation (better known as Interreg).
Authorized persons for data processing	The acquired data are accessible to employees of the Autonomous Region Friuli Venezia Giulia – Central Directorate for Finance – Specialized Operational Unit (UOS) for the management of ERDF community resources and supplementary regional programmes, in particular to members of the Managing Authority and/or Joint Secretariat of the Interreg Programme VI-A Italy–Slovenia 2021–2027, to support staff of the Data Controller and designated Data Processors. The data will be processed in compliance with the principles of fairness, lawfulness, transparency, relevance, and non-excessiveness with respect to the purposes of collection and subsequent processing. The persons who process the data are bound not only to compliance with privacy regulations but also to professional secrecy.
Recipients or Categories of Recipients	 Personal data collected during the implementation of the Programme may be disclosed to other public administrations or members of the Monitoring Committee solely for the institutional purposes set out above. Communication and disclosure to third parties Recipients of personal data are appropriately trained and ensure a level of security equivalent to that of the Data Controller. Data may be disclosed, for legal or institutional purposes, to other independent Data Controllers, including public or private entities such as: European Commission OLAF Programme Partners (Autonomous Region Friuli Venezia Giulia, Veneto Region, Republic of Slovenia) Programme Authorities and Structures Italian Republic Presidency of the Council of Ministers / Department for Cohesion Policies and the South

Retention Period of Personal Data	Personal data shall be retained for the period necessary to achieve the purposes for which they are processed and in accordance with applicable regulations on the retention of administrative and digital documentation. With specific reference to <i>State Aid</i> granted under Regulation (EU) No. 651/2014 – General Block Exemption Regulation (GBER), personal data shall be retained for no longer than 10 years from the date of the last aid granted under said scheme. Personal data subject to publication, as required by current legislation (Article 49 of Regulation (EU) 2021/1060), shall be removed two years after the date of initial publication.
