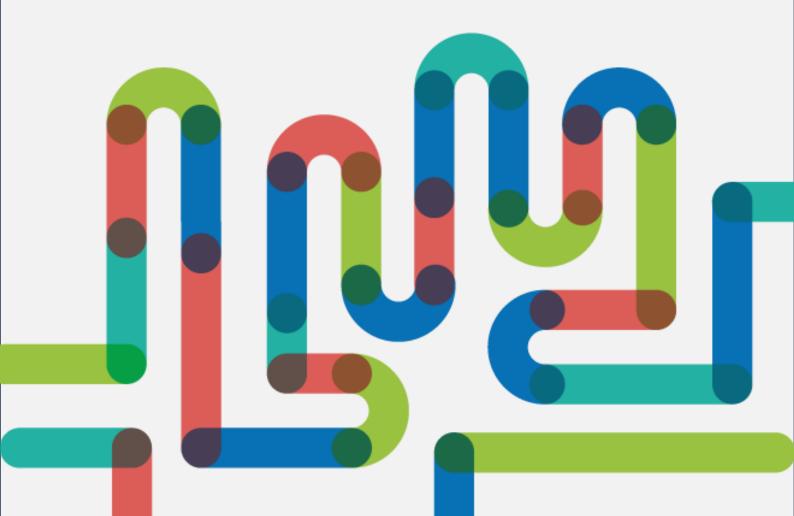

A specification shall be included in the ADRIONCYCLETOUR Invitation Letter about the fact that ADRIONCYCLETOUR has been proposed as an EUSAIR flagship project to be embedded into 2021- 2027 programming documents labelled by EUSAIR as a cross-pillar project by TSG2 (transport sub-group), in cooperation with TSG4 (tourism).

The Capitalisation call and its package will be approved through a written procedure, following an urgent finalization of Annex A by lawyers.
