The 4<sup>th</sup> Interreg VI-A Italy-Slovenia Monitoring Committee (MC) meeting takes place in Postojna (Slovenia) at Jamski dvorec on November 14<sup>th</sup>, 2023 (scheduled 12.30 a.m. to 19.30 p.m.) and 15<sup>th</sup>, 2023 (scheduled 09.30 a.m. to 13.15 p.m.).

The meeting is chaired by Ms Laura Comelli, the Programme Managing Authority (MA).

## **DAY 1 - Tuesday, November, 14<sup>th</sup>, 2023**

### **Topic 1 -Agenda approval**

#### **Conclusion - topic 1**

The agenda Day 1 is approved. Point 4 is integrated with request for modifications also from projects POSEIDONE and KRAS/CARSO II.

### **Topic 2 - SPF - first call**

#### **Conclusion - topic 2**

The MC acknowledges the outcomes of the first Small Project Fund - SPF call.

Detailed data regarding the 27 financed small projects will be timely given by the EGTC-GO to the MC.

In next SPF call, special attentions should be dedicate to small projects (up to €100k).

An eventual scrolling down of first SPF call ranking list is discussed. Upon further investigations by Region FVG (not yet available), a written procedure will eventually follow.

A big event, i.e. the **Interreg Annual Event 2025**, announced by the European Commission (EC)'s Desk Officer is going to be co-organised together with the Interreg IT-SI Programme at end of March 2025 in Gorizia and surrounding border area in occasion of the European City of Culture - ECoC 2025.

The event will focus on the future perspective of programming 2028-2035, specifically on the negotiations process on the forthcoming legislative package with the participation of relevant representatives from national and regional level and stakeholders. In mid-December initial meetings among representatives from the EC/Member States/Interreg IT-SI/EGTC-GO are planned for the political commitment to boost a transnational echo of the big event.



A Programme Working Group can be set up to develop, jointly share ideas and brainstorm on content proposals for the animation and side events to be foreseen in the organization of the Interreg Annual Event 2025.

### **Topic 3 - Cross-border governance and interventions on natural hazards for common safety of the Programme area against natural risks. Proposal of reinforcement**

#### **Conclusions – topic 4:**

Modifications to KRAS/CARSO II are approved.

Modifications to ADRIONCYCLETOUR and POSEIDONE regarding the shifting into BL4 for investments cost in the framework of “*Agreements among Public Administrations*” are



considered technical corrections to be performed by the JS. Therefore, as the proposed modification is matter only of technical correction, the MC approval is not needed and modifications are taken onboard by the JS.

In detail, also for future similar cases:

The expenses for the investments in the framework of *"Agreements among Public Administrations"* should be planned and reported under BL4 according to the prescriptions of the *Programme Manual on Eligibility of Expenses*.

In case of reporting within uncorrect BL of the expenses referred to *Agreements among Public Administrations*, the rule to be applied is that the LPs shall request to the JS before the submission of the first report (using the Programme template for request of modifications) to shift costs into the correct BL 4 as technical correction.

The mentioned technical correction will be made *ex officio* upon LP request without any need of approval. In case the request come after the submission of the first report, the modification would be considered and counted as formal request for modification to be approved according to the rules of the Programme.

## **Topic 8 - Monitoring Committee's Rules of Procedures - RoP's modification: Information and technical proposal**

### **Conclusion - topic 8**

The Monitoring Committee delegates the Managing Authority to integrate/modify the *"Monitoring Committee's Rules of Procedures"* with regard to the composition of the Monitoring Committee.
